PROJECT INFORMATION:

- The current WSFCS network infrastructure is 99% Cisco equipment.
- We only need to purchase new hardware to update our current Cisco switching infrastructure and increase wireless coverage in our
 existing Cisco wireless network.
- We already have Cisco Wireless Controllers with licensing for 6000 AP's. We are currently using around 60% of the licenses.
- By standardizing on the Cisco platform, we only have one contact to go through for troubleshooting and submitting support requests.
- We already have employees that are trained on the Cisco platform.
- We are already setup and currently use the Cisco Prime Management System. Cisco's single point of management for wired and wireless infrastructure.

EVALUATION CRITERIA (FOR AUGMENTING CURRENT ENVIRONMENT):

CRITERIA EXPLANATIONS:

- COMPATIBILITY: Compatibility with existing Cisco network infrastructure.
- SUPPORT COMPATIBILITY: Ability of WSFCS IT staff to setup, support, and maintain equipment (based on current workloads).
- PRIOR EXPERIENCE: WSFCS previous experience with purchasing goods or services from vendor.
- COST OF ELIGIBLE GOODS AND SERVICES: Cost comparison for ERATE eligible goods and services.
- COST OF INELIGIBLE GOODS AND SERVICES: Cost associated with non-ERATE eligible goods and services (i.e. staff training for new hardware platform and new support model training for supporting two different environments).

VENDOR EVALUATION NOTES:

- COMPATIBILITY: V3 and V5 scored high because they bid a hardware platform that we already use. All other vendors bid hardware that we do not currently use. While we do know the hardware would work, it would take a lot of revised configurations on current hardware to get there.
- SUPPORT COMPATIBILITY: Our IT staff is trained and already supporting the Cisco platform offered by V3 and V5.
- RELAVENT REFERENCES: V2 did not score well because references were not easily found within documentation. Other vendors
 were rated based on number of and type of references provided.
- PRIOR EXPERIENCE: All vendors scored low because WSFCS as no prior experience ordering goods and services.
- COST OF ELIGIBLE GOODS AND SERVICES: Based on provided information no vendor offered more than 60% off MSRP. Our rating was scaled based on 30 pts for 60% discount. Some vendors offered multiple percentages on multiple platforms so an average was calculated (and rounded up) for an overall percentage. We deducted 1 rating point for every 2% below 60%. V6 did not provide a straight-forward percentage on hardware based on MSRP. Therefore we estimated a percentage and gave them a fair rating.
- COST OF INELIGIBLE GOODS AND SERVICES: All non-Cisco platform vendors rated low.
