Funding Status – FY 2021 and FY 2020

FY 2021:

Wave 1 for FY 2021 was released on Friday, April 16th, for a total of \$681 million including \$25.0 million for North Carolina applicants. The first wave last year was also \$681 million but was issued more than a month later due to a pandemic-delayed close of the application window,

FY 2020:

Wave 51 for FY 2020 was released on Thursday, April 15th, for a total of \$2.68 million, none for North Carolina applicants. Cumulative commitments are \$2.31 billion including \$73.2 million for North Carolina. Nationwide, USAC has now funded 98% of the FY 2020 applications representing 86% of the requested funding.

E-Rate Updates and Reminders

Upcoming E-Rate Dates:

April 22 Form 486 deadline for FY 2020 covering funding committed in Wave 35. More generally, the Form 486 deadline is 120 days from the FCDL date or the service start date (typically July 1st), whichever is later. Upcoming Form 486 deadlines are: Wave 36 04/30/2021 Wave 37 05/07/2021 Wave 38 05/14/2021 Wave 39 05/21/2021 Wave 40 05/28/2021 April 23 Deadline for filing reply comments on the FCC Emergency Connectivity Fund ("ECF"). E-Rate Central's reply comments were filed Sunday indicating a broad consensus for funding caps in the initial application window. April 27 FCC webinar on the Emergency Broadband Benefit ("EBB") program for consumers and outreach partners. The webinar, scheduled the same week

that we expect EBB benefits to begin, will provide an overview of the program, eligibility information, and enrollment procedures.

May 10 Legislative deadline for the FCC to promulgate regulations for the Emergency Connectivity Fund ("ECF").

Funds For Learning's 11th Annual E-Rate Survey:

For the past decade, Funds For Learning ("FFL") has been conducting a nationwide survey asking schools and libraries to contribute their opinions and experiences regarding the E-rate program. These surveys have become an increasing important source of information for Congress, the FCC, and USAC to help them evaluate the E-rate program. E-Rate Central believes that FFL's survey is an extremely important vehicle, particularly for policymakers, to understand the needs of the E-rate community. A copy of the 2020 survey results, as provided to the FCC, is worth reviewing to understand the survey's importance. We urge you to participate.

Here's what you need to know:

- The survey is available at <u>https://www.surveymonkey.com/r/21erate</u>. The survey consists of 32 primary questions, plus 6 more optional demographic items. It should take less than 10 minutes to complete.
- Survey results are completely confidential. Only aggregate data is reported.
- Funds For Learning, which like E-Rate Central is an E-rate consultant, does not use survey responses as a marketing tool. Were we not confident in the integrity of FFL's survey process, we would not be encouraging you to participate.

Last year, responses were received from approximately 10% of the E-rate applicant base. Given the importance of this survey to the entire E-rate community — applicants, service providers, administrators, and particularly policymakers — we would like to see even greater participation this year.

USAC News Brief Dated April 16 – New USAC Invoicing Dataset

<u>USAC's Schools and Libraries News Brief of April 16, 2021</u> describes a new USAC Open Data resource to be posted this week that will provide information on invoice line items (BEAR and SPI) for all funding years beginning with FY 2016. - How do I know which data I will find in a dataset?
- Does each dataset come with an associated tool for manipulating data?
- How do I learn more about Open Data?
- Where do I go if I have questions?
