# **Funding Status – FY 2021**

Wave 12 for FY 2021 was released on Thursday, July 1<sup>st</sup>, for a total of \$63.5 million including \$564 thousand for 12 North Carolina applicants. Cumulative commitments are \$1.51 billion including \$54.4 million for North Carolina. Nationwide, USAC has now funded 82% of the FY 2021 applications representing 51% of the requested funding.

### **ECF Resources**

The Emergency Connectivity Fund ("ECF") application opened last Tuesday, June 29<sup>th</sup>, and will close August 13<sup>th</sup>. Although questions regarding program details still abound, both the FCC and USAC have been diligently addressing many of them. 	file a BEAR. USAC asks applicants to refrain from using the BEAR system
	until Monday, July 12 <sup>th</sup> .

August 13 Closing date for the initial Emergency Connectivity Fund ("ECF") window.

### FCC Streamlined Decisions:

The FCC issued another set of "streamlined" precedent-based decisions (<u>DA 21-745</u>) last week. As with past streamlined decisions, applicants facing similar problems as those addressed in these decisions may garner useful information by carefully reading the additional FCC explanations found in the footnotes. The original appeal and waiver requests can be found online in the FCC's <u>Search for Filings</u> under Docket 02-6.

In June's streamlined decisions, the FCC:

### 1. Granted:

- a. Three Requests for Review overturning USAC denials for ineligible services.
- b. Four Requests for Waiver of late-filed Form 471 applications due to circumstances beyond the applicants' control.
- c. 49 Requests for Waiver of late-filed Form 471 applications filed within 14 days of the close of the FY 2021 window.
- d. 99 Requests for Waiver of late-filed Form 471 applications filed more than 30 days late. The decision extended a special COVID waiver principle, previously applied to late FY 2020 applications, to similarly delayed FY 2021 applications. The FCC

- warned that this additional relief applied only to this subset of applications and that applicants should not expect additional waiver grants "absent a showing of extraordinary circumstances."
- e. Two Requests for Review or Waiver for not meeting the service substitution request deadline but otherwise complying with the rules and with a "reasonable explanation" for missing the deadline.

### 2. Denied:

- a. One Request for Waiver of the Red Light Rule for failure to satisfy an FCC debt.
- b. One Request for Review for improper service provider involvement in the Form 470 process. Applicant FRNs involving service providers other than the selected vendor were remanded back to USAC for further determination.
- c. One Request for Waiver for an invoice deadline extension.
- d. One Request for Review involving invoicing for products or services not on the applicant's Form 470.

# USAC News Brief Dated July 2 – Update on the FY 2022 Form 470 and BEAR

<u>USAC's Schools and Libraries News Brief of July 2, 2021, covers two changes to E-rate forms.</u>

The Form 470 for FY 2022 was deployed within EPC on July 1<sup>st</sup>. As previewed in USAC's <u>News</u> <u>Brief of June 25<sup>th</sup></u> and our <u>newsletter of June 21<sup>st</sup></u>, the revised Form 470 includes the following changes:

- Separate screens for Category One and Category Two service requests
- Tiered guiding statements to assist users in their selections for service and function types
- Alert messages and requirements for special circumstances related to certain function types
- "Save & Create Another Request," "Save Request," and "Cancel" buttons added for entering service requests
- Shortcut to create a related Basic Maintenance request under Internal Connections
- Additional text added to Internal Connections drop-down options that includes licenses and other associated options

The News Brief also provides additional information on an important change in the BEAR Form system eliminating the separate BEAR PIN requirement. The non-PIN BEAR system will become available July 12<sup>th</sup>. USAC notes the following important points:

- BEARs will be filed from within the EPC system rather than in a separate BEAR system
- USAC will transfer current BEAR Form filing credentials into EPC
- BEAR filers for multiple BENs who had been using different email addresses can consolidate all their BENs under a single address by completing a BEAR access template
- BEAR filers who have not had EPC access will need to be set up as a new EPC user by their BEN's EPC account administrator
