

Important Dates

- Open for 15 days
- Opens Thursday, April 28, 2022



Closes Friday, May 13, 2022



• There will be no Out of Window filing

Important Dates, cont.

Window 1 and 2 applications have already had service end dates extended for schools to utilize a total of 12 months of service – see this <u>newsbrief</u>

Window 3

- Services/Equipment receipt on or after July 1, 2022
- Services/Equipment receipt before December 31, 2023
- Only for a total of 12 months of service

Eligible for Funding

- Maximum \$400/device
 - Laptop/Chromebook/Tablet
 - Bundle Google license into the cost for the device
 - Include a line item for taxes up to the maximum cost of \$400/device (Ex: 7% tax = \$28)
- Maximum \$250/modem/router
 - Bundle firewall into the cost for the monthly service
- Unmet Need
 - Break/Obsolete since pandemic began
 - Increase in students/teachers
- Year X of leased equipment to the above max

Narrative When You File New to Window 3

- USAC needs to confirm NO DUPLICATIVE funding requests
- If you filed in previous windows, you must declare:
 - ECF F471 #, e.g. ECF2021000000
 - Service End Dates for that application
- Unmet need, e.g.
 - Should include numbers used in W1 and W2, i.e. 530 not 30
 - Since pandemic "x devices licensing expired"
 - Growth in enrollment
 - Aged devices, i.e. six-year old laptops
 - Sufficient to engage in <u>remote learning</u>

Will I Be Funded?

- The FCC has estimated approximately \$1B left after the initial filing windows
 - \$4.67B Window 1 applications
 - \$1.14B Window 2 applications
- Additional funding may be "returned" adding more to the bucket
- If and only if, requests exceed available funding, the FCC will begin prioritizing applications

Will I Be Funded, cont.

• Funding will be prioritized based on your E-rate Cat1 Discount Percentage and Urban/Rural Status

< 1	20	30
1-19	40	55
20-34	50	65

After I File...

- Be prepared for PIA reviews
 - Student enrollment changes
 - EOL devices
- Proof of non-duplicative requests
- "New" 12-month service request
 - Previous contract expiration
 - New student/teacher needs
