FY 2023 Application Window

The FY 2023 Form 471 application window will open on **Wednesday, January 18, 2023**, at 12:00 noon EST, and will close on Tuesday, March 28, 2023, at 11:59 p.m. EDT.

USAC's <u>Special Edition E-Rate News Brief of December 21st</u>, announced the FY 2023 window, provided tips for first-time filers, Category 2 budget planning, competitive bidding, and browser updates. Most immediately, the News Brief reminded applicants to update their EPC entity profiles before the close of the Administrative Window that is scheduled for **Monday**, **January 16th** at 11:59 p.m. EST. Once the Administrative Window is closed, entity profiles will be locked for the duration of the application window unless changed during PIA review.

Funding Status for E-Rate and ECF

E-Rate for FY 2022:

Wave 38 for FY 2022 was issued on Thursday, January 5th, for \$3.98 million, none for North Carolina Cumulative commitments to date are \$2.80 billion including \$\$66.9 million for North Carolina. Nationwide, USAC has funded 98.1% of the FY 2022 applications representing 93.5% of the requested funding.

ECF for 2021-2023:

Wave 15 for Window 3 was <u>issued</u> on Wednesday, January 4th, for \$34.4 million including \$2.15 million for six North Carolina applicants. Total commitments for all three ECF windows are \$6.47 billion including \$182 million for North Carolina. Nationwide, USAC has funded 79.4% of the ECF applications representing 65.4% of the requested funding. Window 3 applications are now being funded down to the 75% rural band; Window 3 applications in the 65% rural band are currently under review. Total disbursements as of last Friday remain \$2.56 billion.

Gigi Sohn Renominated for FCC Commissioner:

Gigi Sohn, who had initially been nominated as the fifth FCC Commissioner, but whose confirmation languished in an evenly divided Senate, has been renominated for that position by President Biden. With a slight Democratic majority now in the Senate, prospects for confirmation have improved. The addition of a fifth FCC Commissioner should break an apparent tie on several FCC issues — including, from an E-rate perspective, the approval of a Declaratory Ruling on the eligibility of WiFi on school buses as early as FY 2024.

Statements in support of Ms. Sohn's confirmation were issued last week by FCC Chairwoman Rosenworcel and Commissioner Starks.
