## **FY 2023 Application Window Closes Tomorrow**

The FY 2023 Form 471 application window will close tomorrow, Tuesday, March 28, 2023, at 11:59 p.m. EDT — see <u>USAC's E-Rate News Brief dated February 16<sup>th</sup></u>. Many of the submitted FY 2023 applications are already designated as "Wave Ready" and are likely to be approved in the early funding waves expected to begin in late April.

Extended Customer Service Center ("CSC") hours for the final two days of the application window will be:

8:00 a.m. to 10:00 p.m. EDT on Monday, March 27<sup>th</sup> 8:00 a.m. to 11:59 p.m. EDT on Tuesday, March 28<sup>th</sup>

### **Funding Status for E-Rate and ECF**

# *E-Rate for FY 2022:*

Wave 49 for FY 2022 was issued on Thursday, March 23<sup>rd</sup>, for \$15.3 million, none for North Carolina. Nationwide, USAC has funded 98.6% of the FY 2022 applications representing 96.7% of the requested funding. Cumulative FY 2022 commitments to date are \$2.86 billion including \$71.1 million for North Carolina.

### ECF for 2021-2023:

Total commitments for all three ECF windows are \$6.62 billion including \$189 million for North Carolina. Nationwide, USAC has funded 86.2% of the ECF applications representing 67.6% of the requested funding. Window 3 applications are being funded down to the 65% rural band. Total disbursements as reported March 24<sup>th</sup> were \$2.96 billion.

### USDA Proposal to Lower CEP Eligibility Threshold:

On March 22, the U.S. Department of Agriculture ("USDA") announced a <u>proposed rule change</u> that would lower the Identified Student Percentage ("ISP") threshold for schools and districts to participate in the Community Eligibility Provision ("CEP") from 40 percent to 25 percent. If adopted, this would permit and encourage more schools and districts to participate in the CEP program and likely raise E-rate discounts for some applicants with NSLP percentages currently under the next higher E-rate discount band. Comments on the proposed change are due May 8<sup>th</sup>.

### ESH Apartment Wi-Fi Initiative:

EducationSuperHighway ("ESH") conducted a webinar last week entitled *Apartment Wi-Fi:* Leveraging Grant Funding to Increase Property Value and Resident Satisfaction (recording). The webinar, aimed at apartment building owners, is part of a broader ESH initiative to provide affordable internet to low-income families in multi-tenant housing complexes. This is an effort that schools can support to help ensure adequate home internet access for their apartment-based students.
